Family Requirements

- Meet Volunteers Stingrays may be asked to time at away meets. Meet Officials may be required.
- Home Meets Stingrays asks all families to assist with swim meet duties to have a smooth running event. All families are expected to participate.
- Stingrays Swim Team will also be engaged in the community and social events; Family participation is expected/required and much appreciated.

Safety and Behavior

Stingrays Swim Team wants all activities (practices and social activities) to be safe for swimmers, coaches, families, and spectators. We ask that all members follow the rules of the Four Seasons Health & Fitness and Four Seasons Stingrays Swim Team. All Stingrays Swim Team swimmers are expected to demonstrate good sportsmanship and act as appropriate ambassadors for the team. They should serve as role models for other swimmers.

Locker Rooms

Stingrays Swim Team Coaches are not in charge of supervising swimmers once they have entered the locker rooms. Individual families must be responsible for their swimmer(s) in the changing areas. The locker room should be used expedient and left in the same state where they were found. Any swimmer caught defacing property at any Stingray-related activity will encompass a meeting with the athlete, family, and coach(s) to review the situation to determine disciplinary action. Families will not be refunded when an athlete misses practices due to a disciplinarian action.
